You understand that details on term fees and dates can always be found by visiting one of the following web pages and that late fees do apply to late payments unless an alternative arrangement has been made and agreed with the principals. Late fees are 10% of the total and fees more than 3 days late will incur additional charges. Unfortunately when term fee payments have been made, these are non-refundable.
